### **Annual Report - 2019**

Again, it gives me great pleasure, as your president, to present this consolidated annual report for your perusal, and for presentation to our Annual General Meeting to be held Monday 3<sup>rd</sup> February 2020 at the Gisborne Golf Club.

#### **President's Report**

Having just completed my 3<sup>rd</sup> year as President of the Hume Veterans Golf club, I thank you, the members, for that privilege and for your support throughout the year.

Another very successful year that we can all be proud of.

I am a strong believer that individuals should not stay in leadership positions too long and I think that 3 years is an ideal tenure for groups such as ours. It gives individuals an opportunity to work with the group, and their various committee colleagues, to develop any ideas, be they for improvement or consolidation of the platform that has been left by previous committees.

As I said, in my report last year, clubs are the domain of the membership. Individuals, no matter how positive their contribution or how much they enjoy their role need to manage their time in such roles so that they can move on and afford someone else the opportunity to serve. Longer tenures limit the opportunities to take advantage of other skillsets that are more than likely available.

I am extremely proud of this club and I am, similarly, extremely proud of my efforts as President and my previous three years as Captain.

During that time I consider that the administration of the club matured immensely and whilst I have been proud to lead this change I could not have done it without the support of you the members and, particularly, the support that I have received from the various committee members during this time. We are strong and happy group and I hope that it stays that way for many years to come. Thank you to you all, committee and members alike.

In stepping down as President, I am not walking away from the group. I will be staying on the committee, continuing as Tournament Coordinator for several events during the year and, also continuing my role as Webmaster, looking after the further development and administration of the club website.

Also, Alan has asked me take on the role as Vice President for the next 12 months to assist him in his transition to the President role. Personally, I don't believe that he will need much assistance as he is a very capable person and I am looking forward to working under his direction.

I am not going to single out individuals but for one. Captain Tony is also stepping down after three years in the role. Tony is to be commended for his efforts and the energy, and

passion, that he put into his role as Captain. Tony has been an excellent foil for me as President and I thank him for his efforts on behalf of you the members.

I held a final committee meeting with the outgoing committee, on Monday 20<sup>th</sup> January, at Koorungal Golf Club, where we reviewed our past year's activities and laid the foundation for the year ahead. Again, as I did last year, I am informing you that you, the club members, shouted the committee lunch after that meeting. I thought this a more than reasonable gesture towards thanking your hard-working committee for their efforts this past year. It was very nice, thank you!

### **The Year in Review:**

Apart from the effort that goes into putting together the monthly program of events for everyone's enjoyment I thought that it might be worth highlighting some of the complimentary activities performed by the committee that keep the club functioning.

**Match Calendar:** The annual match calendar was well received again this year. The inclusion of Club Mandalay was considered a success, and everyone seemed pleased.

The average attendance at our monthly events was 90.8 (an average of 8 players per game down on last year but still very healthy).

Mandalay had the highest attendance of 112 whilst the lowest attendance of the year was at Yarrambat with only 63. The committee has reviewed the event at Yarrambat and agree that there were extenuating circumstances that held back the numbers for this event and we are confident that this will improve again in 2020. Our Mt Derrimut event in June was disrupted by weather and had to be postponed. This resulted in a final attendance of 72 when the numbers on the original day were closer to 100.

It was disappointing that we did not get the take up for the annual away trip to Barham, but the interest simply wasn't there to justify going ahead. I am sure that future committees will take another look at this.

Overall, extremely healthy!

### **Membership:**

Mario's membership report is attached but I would like to remind everyone to continue to try to introduce new members to our group. New members are the life blood of any club and, particularly, a club like ours where for some reason we keep getting older so it is important to make sure that we replace those whose golfing days come to an end.

### **Female Membership:**

We recently had our first enquiry from a female golfer about her joining our club. That has not progressed any further at this time, but members should be aware that it is inevitable that we will become a mixed gender club at some time in the future.

This is not something that will be a choice for existing members to make, it will simply be a fact of life that should a female be nominated for membership and she meets the criteria for membership, i.e., 55 years of age, or over, and a member of a golf club with a club handicap, then the committee will have a responsibility to consider that application in the same way that it would for any other.

Equal opportunity legislation, and the guidelines provided by Golf Australia (GA), clearly prevent discrimination in this regard.

The new World Handicapping System (WHS), GA Operating Guidelines, and third-party systems such as Golf Link, facilitate the conduct of multi tee (medley) events and most golf clubs are going in this direction. It is a direction that, we as members, need to be prepared for and if there is any bias, against such a move, then I recommend that we need to get over that bias and move forward as it is not a matter of choice.

I recommend that we embrace such change, when it comes, and continue to enjoy our golf.

**On-Line Payments:** On-line payments, for event, is now coming into its second full year. It is disappointing that more members are not using as it is extremely helpful to the committee and cuts the administration significantly.

It is still our ambition to establish a more robust process and to ultimately achieve a target of having more than 90% of player entries being pre-paid. To this end, I will be working with our software provider in the coming months to improve the process. Following this we will undertake an education process for members to try and improve the uptake.

Thank you all again for your support. I look forward to a most enjoyable 2020 golfing year under the leadership of incoming President Alan.
